Tax Plan a Bad Deal for Homeowners

The tax reform proposal released last week by Republican leaders in Congress and the Trump administration could lead to a tax on homeownership for millions of Americans, NAR says. Under the "Big 6" framework, the tax code would be changed to eliminate the state and local income tax deduction and nearly double the standard deduction. More

Remodeling Brings Equity and Enjoyment

Homeowners who take on remodeling projects gain not only equity and more resale value in their home, they are also more likely to find satisfaction and enjoyment from their home, according to NAR's 2017 Remodeling Impact Report, which includes input from the National Association of the Remodeling Industry.

Compensation Ordered for RESPA Violation

The Consumer Financial Protection Bureau (CFPB) has filed a consent order that requires a title company found to have violated the Real Estate Settlement Procedures Act (RESPA) to pay up to \$1.25 million in compensation. The company, which the CFPB said received money in exchange for referrals and failed to notify consumers of an affiliated business relationship it had with a title insurance firm, also must enact and seek CFPB approval for a compliance plan. Details.

NAR Supports Appraisal Threshold Increase

NAR has sent a letter to federal banking regulators supporting a proposed increase to the appraisal threshold for federally related commercial real estate transactions, which was last raised in 1994, from \$250,000 to \$400,000. NAR does not support raising the threshold for federally related residential transactions, which is also currently \$250,000. More.
